Dear Friends,

The Harrison Presbyterian Preschool is happy to announce that we will have a summer session again this year.

The camp is for children **3 to 5 years old** and will be in groups of no more than 25 children. All children must have had at least one year of nursery school and must also be fully toilet trained.

The summer program will include group activities in:

- Arts and Crafts
- Science and Nature Walks
- Water Play and Sprinklers (if water restrictions allow)
- Gross Motor Play, Indoor and Outdoor
- Snack Time and Quiet Story Time
- Cooking

We are also planning fun activity days such as Ice Cream Social and others. A calendar of events will go home before the first day of the session.

The session runs from **July 5th through August 13th**, for 6 weeks. Half the fee is due with the application and the balance on or before July 10th. The deposit is non-refundable. There will also be a one-time snack contribution of four cans of juice and two packages of cookies. This will be supplemented with snacks we will make ourselves (jello, ice pops, pudding, fruit salad, etc.).

Please return the application form as soon as possible. The session will be open to the public, however, children who have attended our nursery school will be given preference.
